Regulation No. 15/2020 of Rector of the Medical University of Gdańsk as of February 3, 2020 on the organization of the academic year 2020/2021

Pursuant to art. 23, item 1 and 2 of an Act of 20 July 2018 Law on Higher Education and Science (Journal of Laws of 2018 pos. 1668 as amended), and in conjunction with § 28, item 5 of the MUG Statute as of 3 June 2019, (Annex no. 1 to the Resolution No. 44/ 2019 of the MUG Senate as of 03 June 2019) under § 3 of the Rules of Study (Annex no. 1 to the Resolution No. 22/ 2018 of the MUG Senate as of 23 April 2018)

it is hereby ordered as follows:

The academic year 2020/2021 at the Medical University of Gdańsk begins on 01.10.2020 and lasts until 30.09.2021. The course of the academic year is as follows.

- The examination session dates do not apply to students doing their courses in the block system; in this case the continuous examination session system applies (the examinations are held directly upon completion of the relevant course block).
- Vocational training consistent with the programme of studies is obligatory during the academic year
- Exam dates, holidays and holiday breaks do not apply to 6th year students of pharmacy.
